SUBJECT: Clarification on the Concurrent Receipt of Federal Tuition Assistance and the
Montgomery GI Bill-Selected Reserve Education Benefits

(c) Department of Defense Instruction 1322.17, Montgomery GI Bill-Selected
Reserve (MGIB-SR), January 15, 2015

Qualified Selected Reserve Service members may concurrently receive both MGIB-SR under section 16131 of Title 10, U.S. Code and Federal Tuition Assistance (TA) educational benefits under section 2007 of such title, when enrolled in a half-time or greater program of education.

Enclosure 3, paragraph 1.k, of reference (b) establishes policy that TA payments will not be authorized for any course for which a Service member receives GI Bill benefits that constitute a duplication of benefits paid. Enclosure 3, paragraph 3b, of reference (c) describes the circumstance under which payment of both TA and MGIB-SR will constitute a prohibited duplication of benefits. Paragraph 3b should be construed to establish that providing both TA under section 2007 and MGIB-SR education benefits under section 16131 constitutes duplication of education benefits prohibited by policy *only* when a Service member is enrolled less than half-time in a qualifying program of education.

Consequently, all qualified Selected Reserve Service members are authorized concurrent TA and MGIB-SR benefits when enrolled in a half-time or greater program of education.

Montgomery GI Bill-Selected Reserve (MGIB-SR)
